COMMITTEE GOVERNANCE AND OBJECTIVES

EXECUTIVE COMMITTEE

Chair - Timothy E. Hinkle (Lehigh University)

The Executive Committee is comprised of Board Chair, Vice Chair, Immediate past Chair, Treasurer, Secretary and President. Provides oversight to the various standing committees of the Board and acts on behalf of the Board when needed.

EDUCATION COMMITTEE

Chair - Jeannine O'Callaghan (C. F. Martin & Co., Inc.)

Develops and schedules educational events for the membership including: Roundtable programs, Employer Forums, Webinars and the Annual Conference. Identifies appropriate program resources within LVBCH to conduct these events as well as consulting with other non-business Coalition members.

GOVERNMENT COMMITTEE

Chair- Paul Chuckalovcak (Essroc)

Monitors ongoing developments related to legislation, regulations and their possible affects on LVBCH and its members. Distributes information to LVBCH members directly by e-mail or through postings on the Coalition's website as provisions of the healthcare reform legislation are scheduled for implementation.

HEALTH CARE PURCHASING COMMITTEE

34TH ANNUAL CONFERENCE NAVIGATING A HEALTHCARE SYSTEM IN TRANSITION





When the 34th Annual Conference of the *Lehigh Valley Business Coalition on Healthcare (LVBCH)* convened on the campus of DeSales University in May, it set the stage for one of the most successful annual conferences in the history of the Coalition. Some 200 members and guests were in attendance along with our two premier sponsors *Capital BlueCross* and *Express Scripts, Inc.* In addition, 15 partner-vendors also participated in this year's event giving us one of the largest sponsorships ever. We thank our partners for their continued support of Coalition events.

This year's program "Strategies to Navigate a Health Care System in Transition" certainly touched all the bases as changes wrought with the passage of the Affordable Care Act have created both challenges and opportunities for all stakeholders. Once again, as is custom for **LVBCH** events, the program was second to none, featuring three major national speakers who addressed the critical stakeholders in the transitory health care system: consumers, providers and employers.

LVBCH continues to showcase its commitment to providing excellent programs for its members as well as the business community at large and the communities we serve.

Opening the program was *John Santa, MD*, Director, *Consumer Reports Health Ratings* Center. Dr. Santa spoke about *Consumer Reports* program "*Choosing Wisely, Helping Healthcare Consumers Figure Out What To Do and Not To Do.*" As the name implies, *Choosing Wisely* is an initiative of the ABIM Foundation to help physicians and patients engage in conversations about the overuse of tests and procedures and support physician efforts to help patients make smart and effective care choices. The purpose of *Choosing Wisely* is to have consumers become more engaged in their care and take ownership, as they become true partners with healthcare providers. Dr. Santa was sponsored by *BSI Corporate Benefits.*







Delivering the Keynote Address "Making Health Care Work for Everyone: We're All in this Together" was Reed V. Tuckson, MD, Managing Director, Tuckson Health Connections, LLC. Dr. Tuckson's enthusiastic approach encourages engagement on the part of both consumers and providers. An example of his program is healing stories where people describe how they maintain or regain their health. Being an innovator, Dr. Tuckson looks to engage health professionals in the debate, because as he says, we're all in this together. Closing the program, and speaking to employer concerns, was *Laurie Brubaker*, President of Aetna's PA, DE and WV markets. Ms. Brubaker's address, "The Healthy Company in a Healthier World" struck a chord with employers because she touched on those issues that most affect employers and communities as the healthcare marketplace is changing. The core of her presentation is that developing a healthier company and community can be achieved but not without the concerted efforts of employers, communities and healthcare systems. Mayhugh and Gustafson spoke on "Detecting, Preventing and Responding to Violence in the Workplace."

Express Scripts Conducts Broker Event

Express Scripts, Inc. conducted a presentation to brokers on the benefits of offering their clients the LVBCH prescription drug program. Conducting the event from Express Scripts were **Josh Sturm, Sr. Director - Strategic Relations, and David Audie (L), Sr. Director, Clinical Program Management**. Our Broker Partners are well situated to aid their clients in maximizing the dollars they spend on employee benefits. By steering their clients to the LVBCH prescription program, their clients can experience real savings as reflected in the material presented to the group. The take away is that fully insured groups can realize savings of 15-25 percent, while self-insured employers can realize a savings of 13-18 percent. With the cost of prescription medications on the rise, and newer, higher-priced specialty drugs coming onto the market, employers can't afford not to explore the LVBCH prescription drug program.



UCCI Dental Employer Forum: "The Missing PIECE of Total Health"

James B. Bramson, DDS, chief dental officer, United Concordia (L), conducted the session on the role dental health plays in the overall health of individuals. He called attention to the fact that periodontal disease—commonly called gum disease—affects some 47 percent of the adult population. He cited studies that demonstrate that poor oral health can affect and impact general health. Dr. Bramson cited a United Concordia and Highmark study, "Impact of Periodontal Therapy on General Health: Evidence from Insurance Data for Five Systemic Conditions," published in the American Journal of Preventive Medicine, August 2014. Overall, the study concluded that treatment of periodontal disease can reduce medical expenditures in certain chronic disease patients.







Wellness Engagement Workshop

Lehigh Valley Hospital-Muhlenberg was the setting as Certified and Master Certified Health Education Specialists from *Valley Preferred's BeneFIT Corporate Wellness Team* facilitated the event. The goals of the session were: Defining engagement in your company's wellness program; Assessing cultural elements that contribute to overall engagement; Simple steps to help your company get out or stay out of an engagement rut; Tools to implement engaging wellness initiatives with measureable outcomes in the future.

New Publications Focus on the Health of Communities Served by LVBCH



"Closing the Gap in Obesity Management Solutions" is a combined production of LVBCH, The Benfield Group and Eisai, Inc. of Woodcliff Lake, NJ. The data used for this report came from research conducted by The Benfield Group in May of 2012.



LVBCH and Sanofi US (Bridgewater, NJ) produced "Lehigh Valley Business Coalition on Healthcare Type 2 Diabetes Report 2014". The 2014 report includes an overview of key demographics, financial, utilization, pharmacotherapy and health outcomes measures for Type 2 Diabetes patients in the Lehigh Valley, Harrisburg, Reading and Scranton/Wilkes-Barre metropolitan statistical areas.



The CCA is a collaboration of local hospitals, school districts and care providers committed to improving the quality of care for Lehigh Valley children. The CCA has developed a health information exchange called the Virtual Health Village (VHV) which shares children's health care information electronically among health care providers in local

emergency rooms, clinics, physician offices and school health rooms. Electronic sharing will assure faster access and more complete and up-to-date health care information to save time, eliminate duplicate tests and procedures, and greatly improve initial and follow-up care. One of the meetings included a tour of St. Luke's Anderson Campus (a state-of-the-art hospital with 108 patient rooms) led by *Ed Nawrocki, St. Luke's Anderson Campus president (L)*. In addition to standard and surgical services, it also provides specialty services for cancer, heart conditions as well as bone and joint services. The facility opened in 2011 and was the first free-standing hospital built in Pennsylvania in 40 years.

LVBCH Board members met with Lehigh Valley Health Network (LVHN) executives at the health system's newest facility – The Center for Orthopedic Medicine located on Tilghman Street in Allentown. The Board was welcomed to the facility by **Brian Nester, DO,**

Board members learned how LVHN is meeting the challenge to improve healthcare management with a "Triple Aim" approach that focuses on three things: making our community healthier, controlling the cost of care and giving patients the best possible experience. Board members toured the new facility which is a complete orthopedic hospital that provides a full range of procedures on both an inpatient and outpatient basis.

LVBCH continues to serve as a Regional Roll-out Organization for *The Leapfrog Group* responsible for inviting hospitals in Eastern and Central Pennsylvania to participate and complete the **Hospital Survey**. For consecutive years, we have increased the number of participating hospitals. In addition, Leapfrog determines **Hospital Safety Scores** for more than 2,500 general hospitals each year. The score is a letter grade (A, B, C, D or F) indicating how safe each hospital keeps their patients. The more information consumers have about the quality of care in their areas,
