## **LVBCH Employer Group Meetings (March 2020)**

The LVBCH Employer Group Met on March 3rd and 4th in the Lehigh Valley and Reading, respectively. Meeting participants learned about exciting new program launches, including the new provider finder, the latest in government affairs, Geneia updates, and of course, important meeting dates throughout the year.

## **High Performing Network Launch**

Blue Cross Blue Shield Association (BCBSA) is working with all Blue Plans to provide employer groups with access to Blue High Performing Network (HPN), a national network of providers committed to enhancing care quality – all at a lower cost. The savings happen when members visit and get treatment from designated partner providers. In the Lehigh Valley, Capital BlueCross has established an HPN with St. Luke's Health Network. Members will have in-network coverage there – or at one of the 55 (and counting) HPN providers throughout the country. Blue HPN provides a 10% estimated average savings over our PPO products. ## **Provider Finder Update & Enhancements**

Beginning May 1, Capital BlueCross members can start using MyCare Finder, an improved resource that includes:

## **Government Affairs Update**

Capital BlueCross continues to work with local and national government agencies to improve healthcare and increase efficiency. Here are the major legislation positions Capital BlueCross is working toward:

- We are dedicated to ending the practice of surprise balance billing in both the state and federal proposals. We believe the best way to elicit this change is to pay out-of-network providers a market driven rate for services rendered.
- We are opposed to prior authorization legislation as drafted last legislative session.
- With Capital BlueCross Virtual Care, we're continuously working to ensure that our members have access to telemedicine services.
- We are opposed to using long-term antibiotics to treat chronic Lyme Disease. Currently, this
  treatment is still hotly debated in the medical community.
- We remain neutral concerning the removal of prior authorization for metastatic cancer patients.
- Capital BlueCross supports the creation of a State Based Exchange & Reinsurance Program for individual Market.
