# Geisinger Health Plan

### Committed to caring since 1985

Geisinger Health Plan (GHP) is known for providing high quality, affordable healthcare benefits to over 570,000 members. Its roots evolved from a rural, prepaid health plan offered as a pilot program in 1972 to Geisinger Medical Center employees and residents of the five counties that surrounded the hospital.

In 1985, Geisinger Health Plan received its
Certificate of Authority to operate an HMO under
the Pennsylvania Health Maintenance Act of
1973. GHP had a significant premium advantage
during the period of escalating healthcare costs
in the 1980s and 1990s. Membership grew rapidly,
and in 1990, Geisinger Health Plan reached its
100,000-member milestone.

Initially, Geisinger Health Plan was a group practice HMO, meaning its provider network was composed of Geisinger providers only. GHP has since expanded into a network model to better serve members. Sites throughout the service area provide additional convenience to members and better meet the needs of employers.

Today, three companies comprise what is known as Geisinger Health Plan:

- Geisinger Health Plan, a traditional HMO
- Geisinger Quality Options Inc., a preferred provider organization (PPO) plan
- Geisinger Indemnity Insurance Company, which operates as a third-party administrator (TPA) and offers administrative-only services

Geisinger Health Plan provides a variety of coverage options to fit the needs and budget of all Pennsylvanians including:

- Businesses of all sizes
- Individuals and families
- Medicare beneficiaries and Medical Assistance recipients
- Children enrolled in the Children's Health Insurance Program (CHIP)

GHP has received national attention for its ability to foster innovation, while uniquely and effectively managing medical costs and improving outcomes. The passage of the Affordable Care Act in 2010, escalating healthcare costs, a need for different payment models, changes in Medicare reimbursement and an increased focus on quality brought many healthcare market changes.

GHP continues to develop new value-based products to help meet individuals' and employers' needs for plan options. These options provide flexibility in premium and plan design, all while focusing on offering the best member experience possible.



### Our name stands for quality

The superior quality and value of Geisinger Health Plan is no accident. Over the years, we have developed an array of systems and strategies to ensure continuous improvement in the quality of our programs and services.

This high standard is, in turn, reflected in our national rating by the National Committee for Quality Assurance (NCQA). Geisinger HMO, Geisinger PPO and Geisinger Gold's HMO are highly rated among private and Medicare health plans in Pennsylvania for 2017. All three plans received a 4.0 rating on a scale of 5. The rating includes consumer satisfaction, preventive care and treatment measures.

The Centers for Medicare and Medicaid Services (CMS) also provide quality related information to help members choose the highest quality plans available in their area. Geisinger Gold's HMO plan received 4.0 stars on a 5-star rating system in 2017.





### Top-ranked in Pennyslvania

According to the National Committee for Quality Assurance (NCQA) 2018 State of Health Care Quality report, GHP members are more likely to receive recommended preventive screening and medical procedures.

The annual State of Health Care Quality report is designed to provide benefit managers, health plans, consultants, the media and others with easy access to comprehensive information about health plan quality and performance. The report is broken into measures of care and member satisfaction.

Below are some of the areas where GHP excelled:

#### Pennsylvania - Commercial HMO

- #1 for controlling high blood pressure
- #1 for appropriate use of antibiotics for bronchitis
- #1 in blood pressure control for members with diabetes
- #1 in appropriate use of asthma medications for ages 5-11

#### Pennsylvania - Medicare

- #1 for in blood pressure control for members with diabetes
- #1 in adult BMI assessment
- #1 in use of steroid medications to treat members with chronic obstructive pulmonary disease

This means our members receive better care: kids are more likely to see their doctor and receive important immunizations that guard them from illnesses and adults are more likely to receive important screenings and remain on medications which prevent future heart attacks.

#### **Businesses of all sizes**

Our traditional HMO, Geisinger Health Plan, allows employers of any size to provide top-quality coverage for employees and their families. A modified version of our standard HMO comes with a lower premium, but has cost-sharing for some services. In addition, we offer a point-of-service plan where members can choose from our large network of providers or seek care outside the network with a slightly higher out-of-pocket cost. Geisinger Extra encourages members to use a ProvenHealth Navigator® medical home site with lower office visit copayments.

Geisinger PPO plans are available with or without referrals, as well as high-deductible health plans with or without a Health Savings Account or Health Reimbursement Arrangement.

#### Small businesses

Our ACA-compliant small business (1-50 full-time employees) health plans are available to employers with network options that offer a choice of benefit plans at competitive prices.

#### Individual

Geisinger Health Plan offers several ACA-compliant healthcare options across all metallic levels for individuals. Plans are offered in both the federal exchange, Healthcare.gov and Geisinger Marketplace, GHP's private exchange.

#### Medicare

Geisinger Gold plans offer comprehensive healthcare benefits exclusively for Medicare beneficiaries. Medicare Supplement plans are also available throughout Pennsylvania.

#### **CHIP**

Pennsylvania's Children's Health Insurance Program (CHIP), brought to you by GHP Kids, is committed to providing complete care to all eligible, uninsured children and teenagers in our service area.

#### **Medical Assistance**

GHP Family provides quality coverage to Pennsylvania's Medical Assistance (MA) recipients through the HealthChoices program. HealthChoices is Pennsylvania's innovative managed care program for MA consumers.

### Programs to keep you healthy

For members with a complex medical history or specific disorders, GHP's care coordination nurses can help them and their families navigate through the wide variety of services available.

#### Geisinger ProvenHealth Navigator®

Geisinger ProvenHealth Navigator® is a partnership between primary care providers and GHP to improve members' health. Also known as a "medical home," Health Navigator provides a case manager who works closely with the member, their healthcare provider and their family by coordinating care with hospitals, specialists, pharmacists and skilled nursing facilities. Members have access to registered nurses 24 hours a day, seven days a week. This program has significantly reduced the number of hospital admissions and readmissions by providing members an additional resource at the first signs of a complication.

#### Health management

We offer programs that provide members with specialized instruction on how to deal with specific disorders, better manage their symptoms and improve their quality of life in the following areas:

- Asthma
- Diabetes
- Heart failure
- Heart disease
- High blood pressure
- Pulmonary disease (COPD)
- Osteoporosis
- Chronic obstruction
- Tobacco cessation
- Weight management

#### Wellness

We do more to keep our members healthy.

- Tobacco cessation. Professional support provided through phone, individual or group counseling over the course of five sessions. The program goal is to help break an addiction to tobacco products, such as cigarettes, pipes and smokeless tobacco.
- Weight management. The program focuses on developing a healthy lifestyle. Members work with a health manager to set manageable goals, eat healthy and stay active. The goal is to help you take charge of your weight for the rest of your life.
- Health reminders by phone. For members who scheduled a recommended appointment, we'll contact them directly at home with reminders immunizations and important screenings.
- **Prenatal education.** A variety of prenatal classes are available through select hospitals.
- Out-of-network services. If a member is outside our service area and requires medical attention, we'll see to it he or she gets the needed care.
   If necessary, we'll arrange to have the member transported back home to be cared for by his or her own physician.
- Health Risk Assessment (HRA). Members
  have access to a health risk assessment (HRA),
  which provides a current health snapshot and
  evaluates a member's risk for certain health
  conditions. After the HRA is taken, a member will
  receive regular customized health information
  emails.
