LVBCH Announces Release of Fall 2015 Hospital Safety Scores

Local Hospitals Receive New 2015 Hospital Safety Scores Demonstrating Key Strides in Protecting Patients from Errors, Accidents, Injuries and Infections

Bethlehem, PA, October 28, 2015 – The Lehigh Valley Business Coalition on Healthcare (LVBCH) announced today the release of the **Fall 2015 Hospital Safety Scores**, published by patient safety nonprofit, The Leapfrog Group. The Hospital Safety Score grades hospitals on how well they protect their patients from errors, injuries, accidents, and infections. These mistakes harm millions of Americans every year, and it is estimated that up to 440,000 lives are lost each year due to preventable medical errors.

Leapfrog assigned the A, B, C, D, and F letter grades to 2,530 U.S. general hospitals in this latest update. The letter grade is based on 28 national measures and is the most comprehensive safety rating available. It uses the most recent, up-to-date, publicly available data. It is the only tool that focuses exclusively on errors, injuries, accidents, and infections. Other ratings systems look at a variety of factors to rate a hospital, such as patient satisfaction, reputation or procedure-specific outcomes. And, unlike media-run scorecards, the Hospital Safety Score does not rely on advertising, sponsorships or other mass-media concerns to operate.

In Pennsylvania, letter grades were assigned to 131 hospitals with 31 (or 24%) receiving an 'A', the highest letter grade. The only two hospitals in the entire state of PA that have received 'Straight As' since the inception of the Score in 2012 are two local hospitals -- Lehigh Valley Hospital and Lehigh Valley Hospital-Muhlenberg.

"Nearly 1,000 people die every day because of preventable hospital errors. The Hospital Safety Score should be the *first* thing patients and family members consult when faced with a planned procedure or hospital stay," said Tom Croyle, President of LVBCH. "We're pleased to recognize the hard work and commitment of all the following hospitals serving LVBCH employer communities that scored an 'A' letter grade in this latest update:
